

ORDER No. **006533** /MINFOPRA OF **03 AOUT 2018**

To announce a training competitive examination to recruit 80 (eighty) student Sports and Physical Education Tutors (PEPS) and 80 (eighty) student Assistant Sports and Physical Education Tutors (PAEPS) into the National Institute of Youths and Sports (NIYS) Yaounde for the 2018/2019 academic year.

THE MINISTER OF THE PUBLIC SERVICE AND ADMINISTRATIVE REFORM,

Mindful of the Constitution;

Mindful of decree No.75/789 of 18 December 1975 to lay down the Special Rules and Regulations governing the corps of Youth and Sports civil servants;

Mindful of decree No.94/199 of 7 October 1994 to lay down the General Rules and Regulations of the Public Service, as amended and supplemented by decree No.2000/287 of 12 October 2000;

Mindful of decree No.2000/696/PM of 13 September 2000 to fix the General System of Government Competitive Examinations;

Mindful of decree No.2011/408 of 9 December 2011 to organize the Government, as amended and supplemented by decree No.2018/190 of 2 March 2018;

Mindful of decree No.2012/537 of 19 November 2012 to organize the Ministry of the Public Service and Administrative Reform;

Mindful of decree No.2018/191 of 2 March 2018 to reshuffle the Government;

HEREBY ORDERS AS FOLLOWS:

Article 1.- (1) A training competitive examination to recruit 80 (eighty) student Sports and Physical Education Tutors (PEPS) and 80 (eighty) student Assistant Sports and Physical Education Tutors (PAEPS) into the National Institute of Youths and Sports (NIYS) Yaounde is hereby announced for the **unique Yaounde examination centre**, for the 2018/2019 academic year.

(2) The physical part of this competitive examination shall take place on 11 and 12 September 2018 and the written part shall be conducted on 15 and 16 September 2018.

(3) The number of places is distributed as follows:

Article 2. REQUIREMENTS TO SIT THE COMPETITIVE EXAMINATIONS.

a) General conditions:

1. To be of Cameroonian nationality;
2. Be at least 17 (seventeen) years of age and 31 (thirty-one) years at most as at 1st January 2018 (be born between 01/01/1987 and 01/01/2001) for external candidates and 40 (forty) years of age at most as at 1st January 2018 (be born between 01/01/1978 and 01/01/2001) for internal candidates;
3. Be physically fit to work as a Sports and Physical Education teacher;

4. Never have been convicted.

b) Specific conditions:

1 - For the admission into the cycle of Sports and Physical Education Tutors (PEPS)

- For external candidates: be holder of a Bachelor's degree (all options) or any other equivalent diploma issued by a recognised foreign university at the date of submission of file.
- For internal candidates: be Assistant Sports and Physical Education Tutor (PAEPS) with at least 3(three) years of seniority as at 1st January 2018 or be a civil servant of the Armed Forces and Penitentiary Administration, fulfilling the same specific conditions required from external candidates and with at least 3 (three) years seniority as at 1st January 2018.

2- For admission into the cycle of Assistant Sports and Physical Education Tutors (PAEPS)

- For external candidates: be holder of the Baccalaureate diploma of General Secondary Education (all series) or the General Certificate of Education Advanced Level (GCE-A/L) in at least two papers excluding "religious knowledge" or any other recognized equivalent certificate.
- For internal candidates: be Senior Sports and Physical Education Teacher (MPEPS) with at least 3 (three) years of seniority as at 1st January 2018 or be a civil servant of the Armed Forces and Penitentiary Administration, fulfilling the same specific conditions required from external candidates and with at least 3(three) years seniority as at 1st January 2018.

Article 3.- FILE COMPOSITION

(1) The files shall comprise the following documents:

– *For External Candidates:*

- a) a registration form bearing a CFA 1000 francs fiscal stamp. The forms can be obtained at the Ministry of the Public Service and Administrative Reform or all its Regional Delegations or downloaded at the following website address: <http://www.minfopra.gov.cm>;
- b) a certified true copy of birth certificate signed by a competent civil authority;
- c) a certificate of non-conviction;
- d) a certified true copy of the required certificate signed by a competent civil authority;
- e) an attestation of presentation of the original of the certificate signed by a competent civil authority;
- f) a medical certificate issued by a public sector Medical Officer;
- g) an information sheet duly legalized by a competent authority
- h) a receipt attesting payment of the sum of CFA 15 000 (fifteen thousand) francs issued by either the Service Head for Direct and Scholarship Competitive Examinations at the Ministry or the Service Head for Recruitment and Training at the Regional Delegations of the Ministry of the Public Service and Administrative Reform;
- i) a copy of the contract or decision of employment, for the state employee candidate governed by the Labour Code;
- j) two passport-size photographs;
- k) an envelope bearing a CFA 500 francs stamp and the candidate's address.



– *For internal candidates:*

- a) a registration form bearing a CFA 1000 francs fiscal stamp. The forms can be obtained at the Ministry of the Public Service and Administrative Reform or all its Regional Delegations or downloaded at the following website address: <http://www.minfopra.gov.cm>;
- b) a copy of the absorption or reclassification instrument;
- c) a receipt attesting payment of the sum of CFA 20 000 (twenty thousand) francs issued by either the Service Head for Direct and Scholarship Competitive Examinations at the Ministry or the Service Head for Recruitment and Training at the Regional Delegations of the Ministry of the Public Service and Administrative Reform;
- d) an authorization to sit the examinations issued by the Minister of the Public Service and Administrative Reform, after prior approval of the minister under whom the candidate is working;
- e) an envelope bearing a CFA 500 francs stamp and the candidate's address.

(2) Candidates' complete files shall be submitted, against a receipt, at the Ministry of the Public Service and Administrative Reform, Department of State Human Resources Development, (4th floor, Rooms 405 and 409) or in all Regional Delegations of the Public Service, not later than Friday 31 August 2018.

NB:

- Incomplete or late files or files containing documents signed by the police shall not be accepted.
- All documents should be certified by a competent civil, municipal or legal authorities and not more than 3 (three) months old.

Article 4.-TIMETABLE AND MODALITIES FOR THE EXAMINATIONS

The physical, written and oral parts of the examination shall be scheduled as follows:

Article 5. - PUBLICATION OF RESULTS

Results of this competitive entrance examination shall be published through an instrument signed by the Minister of the Public Service and Administrative Reform.

Article 6.- (1) In addition to candidates finally declared successful in these competitive examinations, and in conformity with INJS adopting the **Bachelor-Master's-Doctorate system**, shall equally be admitted into the first year PEPS₁, the 1/3 of PAEPS₃, which are in the graduating classes of the first cycle of INJS.

(2) Admission of these students into the first year of PEPS₁ shall be done through an instrument signed by the Minister of the Public Service and Administrative Reform.

(3) In the absence of candidates from the Armed Forces, Police and Penitentiary Administration, the number of places reserved for the latter shall be allocated to civilian internal candidates.

(4) In the absence of internal candidates or when there is not a quorum, the number of places reserved for the latter shall be allocated to external candidates.

Article 7.- This order shall be registered and published wherever necessary.
